ARTICLES OF INCORPORATION 0F AL COLLIS CONSTRUCTION COMPANY

The undersigned incorporator files these Articles of Incorporation in order to form a corporation under the Florida General Corporation Act.

ARTICLE I

NAME

The name of the corporation is "AL COLLIS CONSTRUCTION COMPANY"

ARTICLE II

DURATION OF THE CORPORATION

EFFECTIVE DATE

This corporation shall exist perpetually unless dissolved according to law.

ARTICLE III

CORPORATE PURPOSE

The purpose of this corporation is to engage in the business of construction and such other business activities, including the ownership of real and personal property, as are necessary or incidental to the operation of the business, or any other lawful business.

ARTICLE IV

AUTHORIZED STOCK

The authorized stock of this corporation shall consist of 100 common shares at \$1.00 par value per share.

ARTICLE Y
