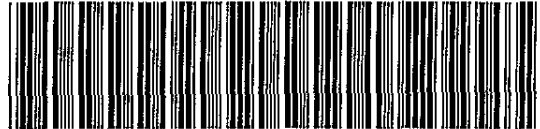



**ARTICLES OF INCORPORATION  
OF  
PRECISION INSTALLERS, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

*Name of Corporation*

The name of this corporation is **PRECISION INSTALLERS, INC.** and the corporate existence shall commence as of the date of the filing of these Articles of Incorporation.

**ARTICLE II**

*Purposes*

The general nature and purpose of business to be transacted, promoted and carried on by the corporation is to engage in every aspect of commercial and residential flooring and such other businesses as may be authorized under the laws of Florida.

**ARTICLE III**

*Principal Office of Corporation*

The street address of the principal office of the corporation is 18833 Sakera Road, Hudson, Florida 34667.

**ARTICLE IV**

*Capital Stock*

a. The maximum number of shares of stock that the corporation is authorized to have outstanding at any time shall be 500 shares of common stock at \$1.00 per share par value. 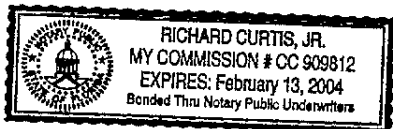


