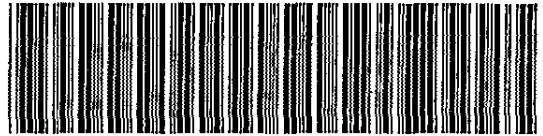

ARTICLES OF INCORPORATION OF ***Shane Martensen Flooring Inc.***

ARTICLE I. NAME

The name of the corporation is:
