SCORETAGE STATES

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act hereby adopt the following Articles of Incorporation.

#### ARTICLE I

#### **NAME**

The name of the corporation is: LİON VIBES RECORDS PRODUCTION INC.

# **DURATION**
