

**ARTICLE I—NAME and PRINCIPAL PLACE OF BUSINESS**

The name of this corporation is STU DAVIS HOME IMPROVEMENT, INC., and its principal place of business shall be located at 332 Kent Drive, Cocoa Beach, Florida 32931.

**ARTICLE II—DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

**ARTICLE III—PURPOSE**

This corporation is organized for the purpose of home repairs and any other business as allowed by law.

**ARTICLE IV—CAPITAL STOCK**

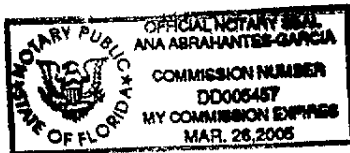
