

ARTICLES OF INCORPORATION OF AERO PARADISE, INC.

The undersigned, for purposes of forming a corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be AERO PARADISE, INC.

ARTICLE II DURATION

The term of existence of the corporation is perpetual.

ARTICLE III PURPOSE

The purposes of the corporation are:


- (a) To engage in the business of specialized commercial truck maintenance.
