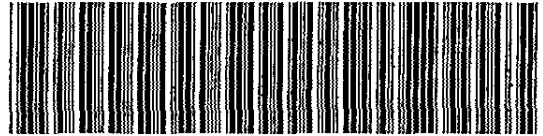



Of

The undersigned, for the purposes of forming a Corporation under Section 607.164 of the Florida General Corporation Act, do hereby certify as follows:

Article I
Corporate Name and Address

The name of the Corporation is **STEVE PRUITT FLOOR COVERING, INC.**, and the street address of the Corporation is:

Corporate Purposes




