ARTICLES OF INCORPORATION

OF THE OWN ONLY The undersigned incorporator does hereby make, subscribe, file and acknowledge these. Incorporation for the purpose of organizing a corporation under the Florida Business Constration Act and the Florida Professional Service Corporation Act for the purpose of engaging in the practice of medicine.

ARTICLE I

NAME OF CORPORATION

The name of this Corporation shall be: Robert J. Hyman, M.D., P.A. (hereinafter, the "Corporation")

ARTICLE II

PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office and mailing address of this Corporation is 10486 Bermuda Errive, Cooper City, Florida, 33026.

ARTICLE III

PURPOSE

The purpose for which the Corporation is organized is to provide medical services and to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.

ARTICLE IV

AUTHORIZED SHARES

The total authorized capital stock of this Corporation shall consist of 10,000 share- of Common Stock, par value \$0.01 per share. Subject to the rights of any outstanding class or series of capital stock ranking senior to Common Stock as to divide ads, dividends may be paid upon Common Stock in cash, property or securities as and when declared by the Board of Directors out of funds legally available therefore. Common Stock shall be entitled to participate in such dividends ratably on a per share besis. In the event of any liquidation, dissolution or winding-up of the Corporation, whether voluntary or involuntary, the holders of Common Stock are entitled to share ratably in the net assets, if any, remaining after payment in full of all debts and liabilities of the Corporation and after the holders of any outstanding class or sories of capital stock ranking senior to Common Stock shall have been paid in full the amounts to which such holders shall be emitted, or an amount sufficient to pay the aggregate amount to which such holders are entitled shall have been set aside for the benefit of the holders of such senior capital stock.
