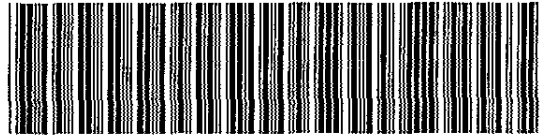


#### ARTICLE X
