

# ARTICLES OF INCORPORATION OF SURE DEVELOPMENT CORP.

The UNDERSINGNED subscribers to these ARTICLES OF INCORPORATION are natural persons competent to contract and hereby form a corporation for profit under chapter 607 of the Florida Status.

#### **ARTICLE 1 - NAME**

# **ARTICLE 2 – PURPOSE OF CORPORATION**

#### ARTICLE 6 - CORPORATE CAPITALIZATION

- 6.1 The maximum numbers of shares that this corporation is authorized to have outstanding at any time is FIVE HUNDRED of COMMON SHARES; each share having the par value of ONE DOLLAR (\$1.00)
- No holder of shares of stock of any class shall have any preemptive right to subscribe to or purchase any additional shares of any class, or any bonds or convertible securities of any nature, however, that the board of directors may, in authorizing the issuance of shares of stock of any class, confer any preemptive right that the board of directors may deem advisable in connection with such issuance.
- 6.3 The board of directors of the corporation may authorized the Issuance from time to time of shares of its stock of any class whether now of hereafter authorized, or securities convertible into shares of its stock of any class, whether now or hereafter, authorized, for such restrictions or limitations, if any, as may be set forth in the by-laws of the corporation.
- The board of directors of the corporation may, by articles Supplementary classify or reclassify any consideration as the board of the directors may deem advisable subject to such restrictions or limitations, if any, as may be set forth in the by-laws of the corporation.

- 7.4 The shares of stock represent by this Certificate cannot be transferred and such transfer would be taxed under Sub-Chapter "S" of the Internal Revenue Code of 1986 as amended.

#### **ARTICLE 8- POWERS OF CORPORATION**
