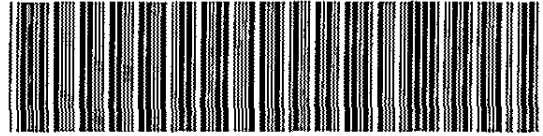



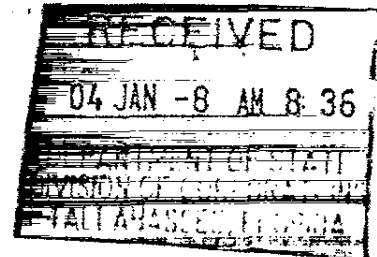

ARTICLE I. NAME

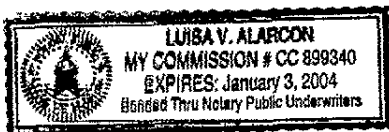
