ARTICLES OF INCORPORATION OF FLPWR.COM, INC.

ARTICLE I Name and Duration

The name of the Corporation is fipwr.com, Inc. The duration of the Corporation is perpetual. This Corporation shall begin its corporate existence as of the date that these Articles are filed by the Secretary of State.

ARTICLE II Principal Office

The address of the principal office and mailing address of the Corporation in the State of Florida is 1910 N. Orange Avenue, Suite B, Orlando, FL 32804.

ARTICLE III Registered Office and Agent

ARTICLE IV Corporate Purposes, Powers and Rights
