**ARTICLES OF INCORPORATION  
OF  
PAPA'S 2<sup>ND</sup> STREET DELI, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I  
NAME**

The name of the corporation is PAPA'S 2<sup>ND</sup> STREET DELI, INC. (hereinafter called the "Corporation").

**ARTICLE II


