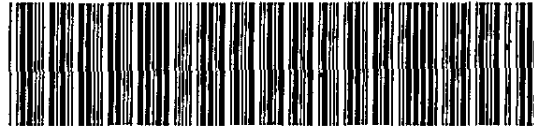


- FIRST: The name of the corporation is Flair Productions, Inc.
