ARTICLES OF INCORPORATION
OF

ARTICLE I

The name of this Corporation is: Nail Capital, Inc.

This Corporation shall exist in perpetuity commencing on the date of execution and acknowledgement of these Articles of Incorporation.

ARTICLE III

This corporation is organized for the purposes of transacting any and all legal business.

ARTICLE IV

This Corporation is authorized to issues 100 shares of \$1.00 per value common stock which shall be designated as "Common Shares."

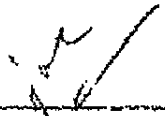

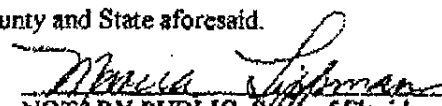

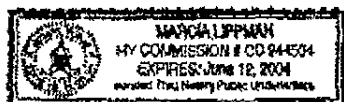
