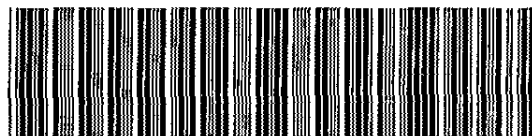

**ARTICLES OF INCORPORATION  
OF  
TERRIE DUCRAY, INC.,  
a Florida Corporation**

The undersigned, acting as Incorporator of TERRIE DUCRAY, INC., a Florida corporation (the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:
