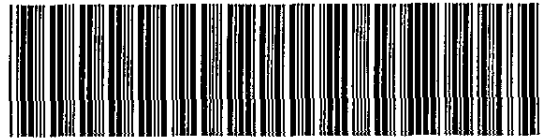

AMENDMENT


