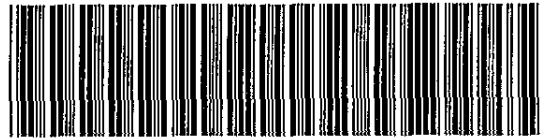

AMENDMENT

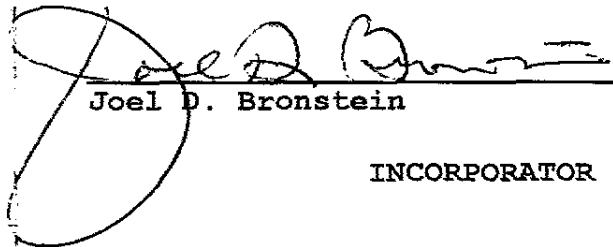
