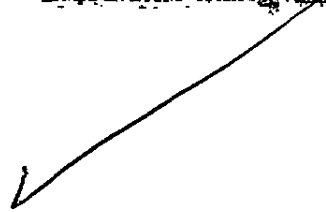


ARTICLE 4. STOCK. The corporation is authorized to have outstanding at any one time 10,000,000 shares of stock at no par value.
