

ARTICLES OF INCORPORATION OF 04 JAN -9 A111:51 AMERICAN ENTERPRISE BANK OF FLORIDA

The undersigned, acting as directors for the purpose of forming a corporation under and by virtue of the Laws of the State of Florida, adopt the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be American Enterprise Bank of Florida and its initial place of business shall be at Suite 100, 4655 Salisbury Road, Jacksonville, County of Duval, and State of Florida 32256.

ARTICLE II

The general nature of the business to be transacted by this corporation shall be that of a general commercial banking business with all the rights, powers, and privileges granted and conferred by the Florida Financial Institutions Codes, regulating the organization, powers, and management of banking corporations.

ARTICLE III

The total number of shares authorized to be issued by the corporation shall be 4,000,000. Such shares shall be of a single class and shall have a par value of \$5.00 per share.
