#### ARTICLE I

#### NAME

The name of the Corporation is Atlantic Woodworks, Inc.. The principal office address and the mailing address of said Corporation is 1888 Mealy Street Atlantic beach, Florida 32233.

#### ARTICLE II

#### DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.
