ARTICLES OF INCORPORATION

OF

The Law Offices of David Luther Woodward, P. A.

In compliance with the requirements of Chapters 607 and 621, Florida Statutes (2003), the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is *The Law Offices of David Luther Woodward, P. A.*

ARTICLE II

The existence of the Corporation shall begin on January 1, 2004.

ARTICLE III

The street address of the principal office of the Corporation is 111 Bayshore Drive, Warrington, Pensacola, Florida 32507-3583.

ARTICLE IV

The purpose of this corporation shall be to render professional services to the public as duly admitted, licensed and practising attorneys-at-law as comprehended by Chapter 621, Florida Statutes, and more particularly, §621.03(2), Florida Statutes (2003).

ARTICLE V

The maximum number of shares this Corporation is authorized to issue is 100 par value \$.01 per share, all of which shall be *Common Shares*. All *Common Shares* shall be identical with each other in every respect and the holders of *Common Shares* shall be entitled to one vote for each share on all matters on which shareholders have the right to vote. No person may be a stockholder in this corporation unless he is a provider of "professional services" as an attorney-at-law as comprehended by §621.03(1), Florida Statutes (2003).

ARTICLE VI

The initial street address of the Corporation's registered office is 111 Bayshore Drive, Warrington, Pensacola, Florida 32507-3583. The initial registered agent for the Corporation at that address is David Luther Woodward.


ARTICLE VIII

The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.


