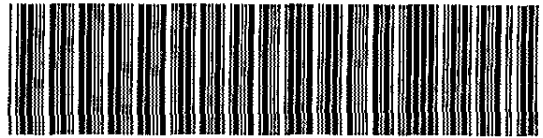

**ARTICLES OF INCORPORATION
OF**

The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the corporation (hereinafter called the "Corporation") is:

DIECAST AND VARIETY, Inc.

SECOND: The duration of the Corporation shall be perpetual.

THIRD: The street address of the Corporation shall be 2801 E. Irlo Bronson Hwy #D50, Kissimmee, Florida 34744 and the mailing address shall be 1014 Florida Parkway, Kissimmee, Florida 34743.

FOURTH: The number of shares which the Corporation is authorized to issue is One Thousand (1000), all of which are of a par value of \$0.10 each and are of the same class and are to be Common shares.

FIFTH: The initial Board of Directors shall have 2 member(s) whose name(s) and address(es) is/are as follows:

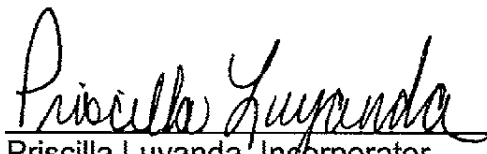

SEVENTH: The name and address of the incorporator is:

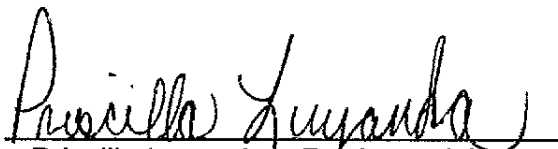

EIGHTH: No holder of any shares of any class of the Corporation shall be entitled as of right to subscribe for, purchase, or otherwise acquire any shares of any class of the Corporation which the Corporation proposes to issue or any rights or options which the Corporation proposes to grant for the purchase of any shares, bonds, securities, or obligations of the Corporation which are convertible into or exchangeable for, or which carry any rights to subscribe for, purchase or otherwise acquire shares of any class of the Corporation; and any and all of such shares, bonds, securities, or obligations of the Corporation, whether now or hereafter authorized or created, may be issued, or may be reissued if the same have been reacquired and if their reissue is not prohibited and any and all of such rights and options may be granted by the Board of Directors to such individuals and entities, and for such lawful consideration, and on such terms, as the Board of Directors in its discretion may determine, without first offering the same, or any thereof, to any said holder.

NINTH: The Corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida statutes.
