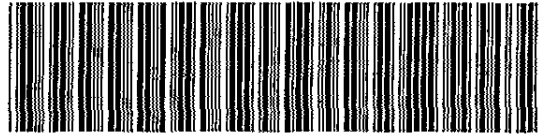

ARTICLES OF INCORPORATION

ARTICLE I NAME

The name of the Corporation is: JOHN FACELLA RESCREENING, INC., a domestic corporation, which is not a member of any affiliated group.

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 221 SE 23rd Pl, Cape Coral, FL 33990.

The principal mailing address of this corporation shall be: 221 SE 23rd Pl, Cape Coral, FL 33990.

ARTICLE III PURPOSE

The general purposes for which the Corporation is organized are:

1. To engage in the business of rescreening services; and
2.
