

ARTICLES OF INCORPORATION

We, the undersigned, have this day associated ourselves together for the purpose of forming a corporation for profit under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation is CARLSON TILE & SMALL HOME REPAIR, INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation shall be: 5791 University Club Boulevard North, #407, Jacksonville, Florida 32277.

ARTICLE III PURPOSE

The purpose for which this Corporation is being formed is to promote the tile and home repair business and free enterprise.

ARTICLE IV SHARES

The number of shares of stock that this Corporation is authorized to have outstanding at any one time is One Thousand Shares of Non-Assessable Common Stock, having a par value of \$1.00.

Shares having a par value may be issued for such consideration expressed in dollars not less than the par value thereof, as shall be fixed from time to time by the sharesholders of the corporation.
