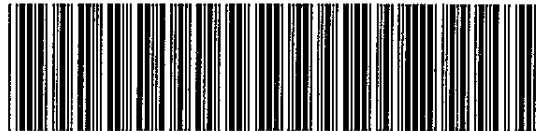

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the state of Florida.

ARTICLE I- NAME

The name of this corporation is **JLR PRESSURE CLEANING, INC.**

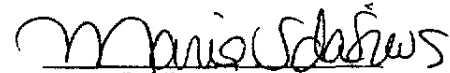
