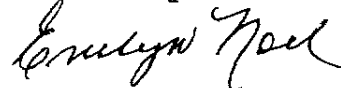

ARTICLE V - TERM OF EXISTENCE

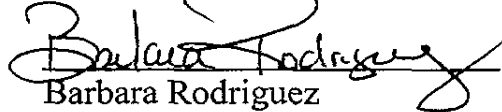
This Corporation shall have perpetual existence.
