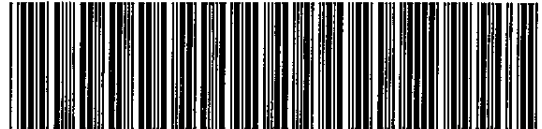

ARTICLES OF INCORPORATION
OF

PURSUANT TO ARTICLE TWO OF THE STOCK CORPORATION LAW

WE, THE UNDERSIGNED, for the purpose of forming a
corporation pursuant to Chapter 607 and/or Chapter 621,
F.S. (Profit) Law of the State of Florida, do hereby
certify:

FIRST: The name of the proposed corporation shall be
FLORIDA DEEP FOUNDATIONS, INC.

SECOND: The purpose for which it is to be formed
are:

To conduct and carry on the business of general
contractors and builders; to design, plan, erect,
construct, equip, alter, rebuild, remodel, improve and
repair all kinds of houses building and other structures or
parts thereof and works and excavations therefor; to
perform all kinds of work in connection therewith; to
employ mechanics laborers, artisans and workmen, and to
make contracts and sub-contracts of work and materials; to
make, purchase, and sell and deal in materials for the
construction and equipment of buildings or of parts thereof
or which may be conveniently dealt in connection with the

business aforesaid; to own, manage, operate, lease, purchase and sell buildings and generally to transact all business of a similar nature necessary or incidental to the purpose aforesaid, and to do all things necessary or incidental thereto or connected with the business of contractors and builders.

To manufacture, purchase, or otherwise acquire, invest in, own, mortgage, pledge, sell, assign and transfer or otherwise dispose of, trade, deal in and deal with goods, wares and merchandise and personal property of every class and description.

To acquire property for the corporate purposes by grant, gift, purchase, devise or bequest, and to hold and dispose of the same, subject to the limitations as may be prescribed by law.

To guarantee any obligation for the payment of money to the extent provided by law.

To acquire, and pay for in cash, stock or bonds of this corporation or otherwise, the good will, rights, assets and property, and to undertake and assume the whole or any part of the obligations or liabilities or any person, firm, association or corporation.

To acquire, hold, use, sell, assign, lease, grant licenses in respect of, mortgage or otherwise dispose of

letters patent of the United States or any foreign country, patent right, licenses and privileges, inventions, improvements and processes, copyright, trademarks and trade names, relating to or useful in connection with any business of this corporation.

To purchase, acquire, hold and dispose of bonds, notes or chooses in action of any person or persons, partnership or corporation and to pledge the same to secure the payment of collateral trust bonds or notes and to sell or otherwise negotiate such collateral trust bonds or notes.

To purchase, acquire, hold and dispose of the stocks, bonds and other evidences of indebtedness of any corporation, domestic or foreign, and issue in exchange therefor its stock, bonds or other obligations.

To borrow money and contract debts, when necessary for the transaction of the business of the corporation, or for the exercise of its corporate rights, privileges or franchises, or for any other lawful purpose of its incorporation and to issue and dispose of obligations for any amount so borrowed and to mortgage its property and franchises to secure and payment of such obligations, or of any debt contracted for such purposes, in the manner authorized by law.

To purchase, hold, sell and transfer the shares of its own capital stock; provided it shall not use its funds or property for the purchase of its own shares of capital stock when such use would cause any impairment of its capital except as otherwise permitted by law.

To have one or more offices, to transact business and conduct its affairs in whole or in part in other states of the United States of America, in the District of Columbia, in any of the territories, districts, protectorates, dependencies or insular or other possessions thereof, or in any foreign countries, and to acquire, hold and dispose of such property therein, real, personal and mixed, as may be requisite for the transaction of its business and the conduct of its affairs.

To have and exercise all the powers conferred by the laws of Florida upon corporations formed under the act hereinbefore referred to, and to do any or all of the things hereinbefore set forth to the same extent as natural persons might or could do.

The forgoing clauses shall be construed both as objects and powers, and it is hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner the powers of this corporation.

THIRD: the amount of capital stock shall be Thirty Thousand Dollars (\$30,000.00).

FOURTH: The number of shares of which the capital stock shall consist is six thousand (6,000) shares of the par value of Five Dollars (\$5.00) per share.

FIFTH: The office of the corporation is to be located at 1280 N Congress Ave Bldg, Suite 201, in the City of West Palm Beach, and State of Florida, 33409.

The address to which the Secretary of State shall mail a copy of the process in any action or proceeding against the corporation which may be served upon him is c/o CT Corporation Systems, 1200 S Pine Island, Plantation, Florida 33324.

SIXTH: The duration of the corporation shall be perpetual.

SEVENTH: The number of its directors shall be two. Directors need not be stockholders.

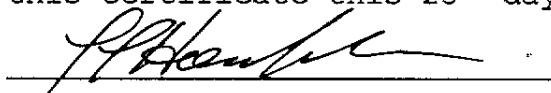
