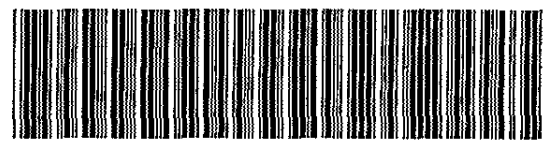

ARTICLES OF INCORPORATION
OF

ARTICLE I. NAME

The name of this corporation is PHILIP CAMERON, INC.

ARTICLE II. DURATION

This corporation shall commence January 1, 2004 and shall have perpetual existence.

ARTICLE III. PURPOSE

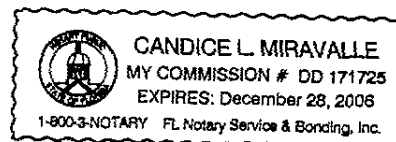
