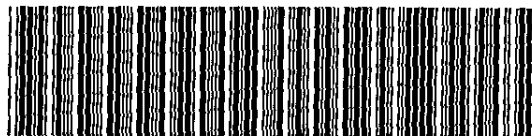

ARTICLES OF INCORPORATION

The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I
Name of Corporation

The name of the corporation shall be:

ARTICLE II
Nature of Business

The general nature of the business to be transacted by this corporation is to provide consulting, marketing and representation services for manufacturers, resellers and distributors and to perform any other activities or business permitted in the State of Florida and such other states as the corporation may duly qualify, in which to do business.

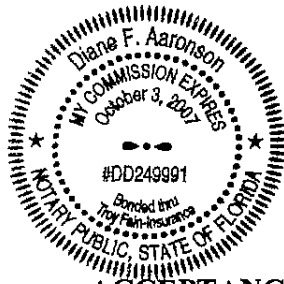
