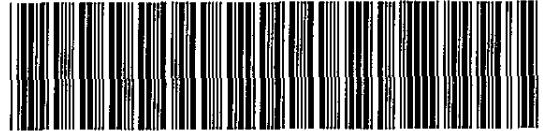


ARTICLE XIII AMENDMENT
