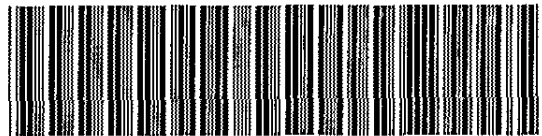

ARTICLES OF INCORPORATION

OF

MURRELL WEISSINGER, P.A.

The undersigned, who is duly licensed to practice the profession of real estate agent in the State of Florida, desiring to form a professional corporation in accordance with the Florida Business Corporation Act and the Florida Professional Service Corporation and Limited Liability Company Act, adopt the following Articles of Incorporation:

ARTICLE I

NAME

The name of the professional corporation is MURRELL WEISSINGER, P.A.

ARTICLE II

PURPOSE

The purpose for which the corporation is organized is to perform the service of real estate sales. The sole and exclusive professional service to be rendered by the corporation is the practice of the profession of the real estate agent.
