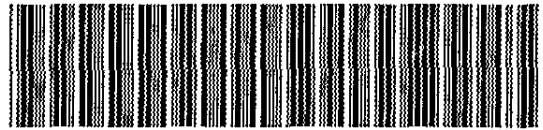

ARTICLE I

Name

The name of this corporation is:

HOME FIELD ADVANTAGE, INC.

ARTICLE II

Duration

This corporation shall have perpetual existence.

ARTICLE III

Purpose
