The name of this corporation is HRA MUSICAL INSTRUMENTS, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence, commencing on January  
12, 2004.

ARTICLE III - PURPOSE

This corporation is organized to transact any and all lawful business as enumerated in the Florida General Corporation Act.


