**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME AND ADDRESS

The name of the Corporation shall be BUILDERS RECYCLING SERVICES, INC., with its principal place of business at 4049 Southeast 130th Street, Belleview, Florida 34420.

ARTICLE VIII - BY-LAWS

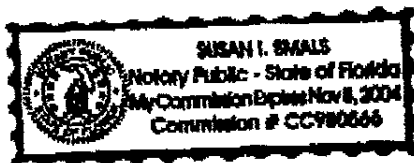
The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and the Shareholders.
