**ARTICLES OF INCORPORATION
OF
PORTFOLIO HOLDINGS CANADA INC.**

THE UNDERSIGNED, acting as sole incorporator of PORTFOLIO HOLDINGS CANADA INC. (hereinafter, the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, as hereafter amended and modified (the "FBCA"), hereby adopts the following Articles of Incorporation for the Corporation, pursuant to Section 607.0201 of the Florida Statutes:

ARTICLE 1

Name

The name of the Corporation is: PORTFOLIO HOLDINGS CANADA INC.

ARTICLE 2

Purpose

The Corporation may, and is authorized to, engage in any activity or business now or hereafter permitted under the laws of the United States and of the State of Florida.

ARTICLE 3

Principal Office and Mailing Address

The address of the Principal Office of the Corporation and its mailing address is c/o Szemenyei, Kirwin, Mackenzie LLP, 376 Richmond Street, London, Ontario N6A 3C7. The location of the Principal Office and the mailing address shall be subject to change as may be provided in the Bylaws.

ARTICLE 4

Capital Stock

The total number of shares of all classes of capital stock that the Corporation shall have the authority to issue shall be 10,000 shares, all of which shares shall be voting Common Stock having a par value of \$0.01 per share, designated "Common Stock." Pursuant to Section 607.0602 of the FBCA, the Board of Directors is authorized, without the approval of the shareholders of the Corporation, to (a) provide for the classification and reclassification of any unissued shares of common stock and determine the preferences, limitations, and relative rights thereof and (b) issue common stock in one or more classes or series, all within the limitations set forth in Section 607.0601 of the FBCA.

Board of Directors

There shall initially be one member of the Board of Directors, who shall serve until the first meeting of the shareholders of the Corporation. Thereafter, the number of directors of the Corporation may be fixed in accordance with the Bylaws of the Corporation.
