ARTICLES OF INCORPORATION OF

RHONDA L. CONLAN, P.A.

The undersigned natural person, acting hereby as Incorporator for the purpose of forming a Professional Service Corporation for profit under the provisions of Section 607, Florida General Corporation Act, and Section 621, Florida Professional Service Corporation Act, of the Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I NAME OF CORPORATION

The name of this corporation shall be RHONDA L. CONLAN, P.A.

ARTICLE II PURPOSES

The general nature and purposes of business to be transacted, promoted and carried on by the corporation are as follows:

- a. To engage in the business of providing the professional service of a sales associate.
- c. To invest its funds in real estate, mortgages, stocks, bonds and any other type of investments permitted by law and to own real or personal property necessary for the rendering of its professional services.
- d. To engage in no other professional service other than the professional service of being a sales associate.
- e. To do everything necessary and proper in accomplishing the purposes herein set forth and to do any thing incidental thereto which is not forbidden under the laws of the State of Florida.

ARTICLE III CAPITAL STOCK

- a. The maximum number of shares of stock that the corporation is authorized to have outstanding at any time shall be 100 shares of common stock at \$1.00 per share par value.
- b. The consideration to be paid for each share shall be payable in lawful money or property, labor or services, and such consideration to be paid for each share is to be fixed by the Board of Directors.
- c. Shares of the corporation stock and certificates shall be issued only to RHONDA L. CONLAN.

ARTICLE IV RESTRICTION ON TRANSFERRING SHARES

No stockholder of this corporation may sell or transfer his or her shares in the corporation.

ARTICLE V DURATION

The corporation shall have perpetual existence.

ARTICLE VI REGISTERED AGENT AND PRINCIPAL OFFICE

ARTICLE X INFORMAL DIRECTOR ACTION

If all of the Directors severally or collectively consent in writing to any action taken or to be taken by the corporation, and the writings evidencing their consent are filed with the Secretary of the corporation, the action shall be as valid as though it had been authorized at a meeting of the Board of Directors.

ARTICLE XI INDEMNIFICATION

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE XII BYLAW AMENDMENT

The power to adopt, alter, amend or repeal the bylaws of this corporation shall be vested in the Board of Directors and Stockholders provided that such amendment be in compliance with the laws of Florida governing a Professional Service Corporation.

ARTICLE XIII INITIAL CAPITAL AMOUNT

The amount of capital with which this corporation shall begin business is not less than \$100.00.
