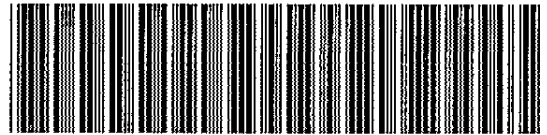

AMENDMENT


