ARTICLES OF INCORPORATION

OF

ERIC DEUBERT, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation.

ARTICLE I. CORPORATION NAME

The name of the corporation is ERIC DEUBERT, INC.

ARTICLE II. NATURE OF BUSINESS AND POWERS

The purpose of the corporation is to engage in any activities of business permitted under the laws of the United States and Florida.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 1000 shares of common stock with \$1.00 par value.

ARTICLE IV. TERM OF EXISTENCE

This Corporation shall have perpetual existence.

ARTICLE V. REGISTERED AGENT AND INITIAL REGISTERED OFFICE

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders

and approved at a stockholders' meeting by at least a majority of the stock entitled to vote,
unless all of the directors and all of the stockholders sign a written statement manifesting their
intention that a certain amendment of these Articles of Incorporation be made.

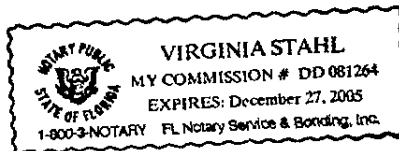
