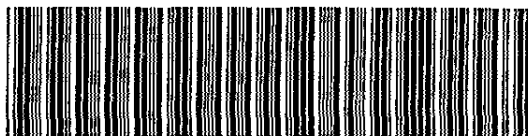

The undersigned incorporator for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

The name and address of the initial registered agent is AMIR HASAN, 760 West Sample Road, Bay 3, Pompano Beach, Florida 33064.


