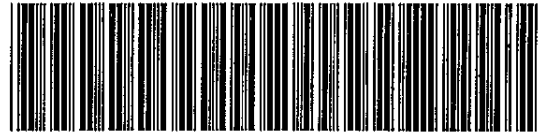

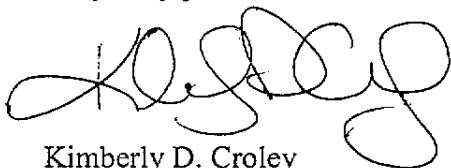

ARTICLES OF INCORPORATION
OF
ZGS FT. MEYERS-NAPLES, INC.

The undersigned does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the corporation (hereinafter called the "corporation") is ZGS Ft. Meyers-Naples, Inc.

SEVENTH: The purposes for which the corporation is organized are as follows:

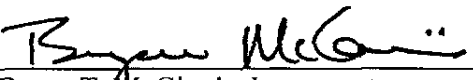
To own and operate television and radio stations.

To engage in any lawful business for which corporations may be organized under the Florida Business Corporation Act.

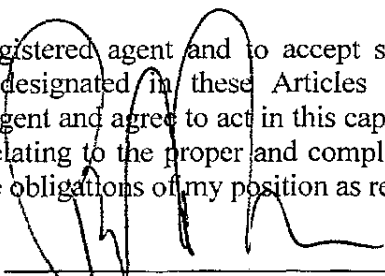
To have all of the general powers granted to corporations organized under the Florida Business Corporation Act, whether granted by specific statutory authority or by construction of law.
