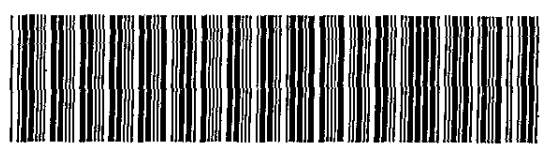

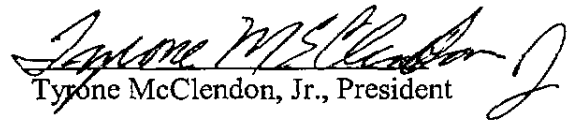
ARTICLE VIII--AMENDMENT
