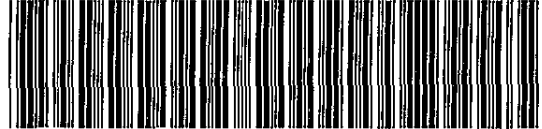

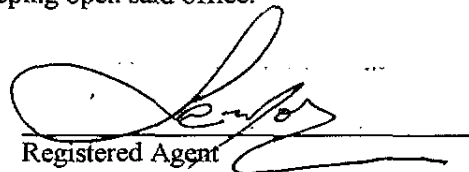

Article XIII – Amendment

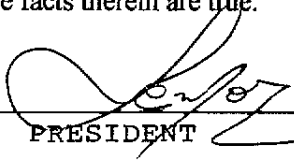

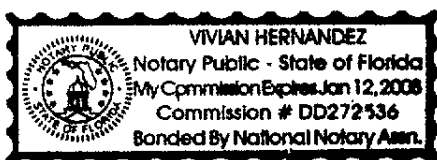

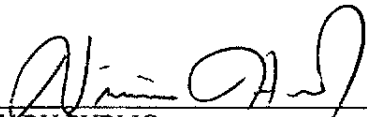
