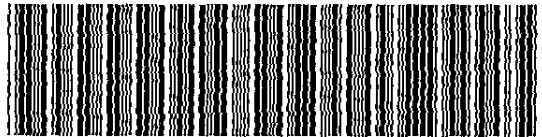

**ARTICLES OF INCORPORATION**

THE UNDERSIGNED do hereby associate themselves for the purpose of forming a corporation under the laws of the State of Florida, and do hereby certify as follows:

**ARTICLE I - NAME**

The name of the Corporation shall be:

**GOLDEN EAGLE INVESTMENTS GROUP, CORP.**

**ARTICLE II - PURPOSE**

A.- To carry on and engage in the business of developing, manufacturing, distributing, exporting, marketing and selling all type of products, domestically and abroad.

B.- To carry on and engage Consulting, Advertising, Publishing and Internet Services domestically and abroad in any business activity.

C.- This company may buy shares of stock of any foreign and/or national companies throughout the world, and all types of investments in any business activity.

**F.- To carry on and engage in any business or activity which may be authorized and permitted by virtue of laws of the United States of America and the State of Florida.**

### **ARTICLE III – CAPITAL STOCK**

**The Corporation shall be authorized to issue capital stock in the following manner, to wit: 10.000.000.- (TEN MILLION) shares of common stock, having no par value.**

### **ARTICLE IV – POWERS**

**The powers of the Corporation shall include all those conferred by the bylaws of the Corporation and the laws of the State of Florida.**

### **ARTICLE V – TERM OF EXISTENCE**

**The Corporation shall have perpetual existence, in accordance with the laws of the State of Florida.**

### **ARTICLE VI – PRINCIPAL PLACE OF BUSINESS**

**The principal place of business of the Corporation shall be:**

### **ARTICLE VII – REGISTERED AGENT AND OFFICE**

**The Registered Agent for the Corporation shall be Katty Chehade, and the Registered Office shall be located at: 7350 N.W. 7 ST. Suite 104, Miami, Florida 33126 or such other person or such other place as the Director or Board of Directors may, from time to time, direct with appropriate notice being given to the Secretary of State, in accordance with the applicable Florida Statutes.**

### **ARTICLE VIII – OFFICERS AND MANAGEMENT**

The affairs of the Corporation shall be managed by its officer and/or officers, subject to the provisions of these Articles of Incorporation and in accordance with the bylaws of the Corporation. The foregoing right of indemnification shall be in addition to and not exclusive of any other rights to which such Director or Officer may be Entitled.

#### **ARTICLE XIII – VOTING RIGHTS**

That except as may otherwise be provided by law, the local voting power for the election of Directors of the Corporation shall be vested solely and exclusively in the holders of the outstanding shares of the capital stock of the Corporation.

#### **ARTICLE XIV – BYLAWS**

The original bylaws of the Corporation shall be adopted by a majority vote of the Shareholders of the Corporation present at a meeting of the Shareholders called for such purpose, at which a majority of the Shareholders are present, and thereafter the bylaws of the Corporation may be amended, altered or rescinded by the vote of the Shareholders of the Corporation.
