The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

CORPORATE NAME AND PRINCIPAL OFFICE

The name of this corporation is BAUER HOLDING GROUP, INC., and its principal office and mailing address is 12529 Sparkleberry Road, Tampa, Florida 33626.

ARTICLE II

COMMENCEMENT OF CORPORATE EXISTENCE

The corporation shall come into existence on the date of subscription and acknowledgment of the Articles of Incorporation.

ARTICLE III

GENERAL NATURE OF BUSINESS

The corporation may transact any lawful business for which corporations may be incorporated under Florida law.
