#### ARTICLES OF INCORPORATION

OF

#### ARE YOU TALKING TO ME, INC.

#### **ARTICLE I**

Name. The name of this corporation is ARE YOU TALKING TO ME, INC.

# **ARTICLE II**

<u>Duration</u>. The corporation shall be perpetual.

#### **ARTICLE III**

<u>Purpose.</u> This corporation is organized for the purpose of transacting any or all lawful business.

#### **ARTICLE IV**
