ARTICLES OF INCORPORATION OF Y&L TITLE, INC.

I, MATTHEW F. YON, the undersigned incorporator of this corporation under Section 607.194, Florida Statutes, as amended, do hereby form this corporation and adopt the following:

Articles of Incorporation.
