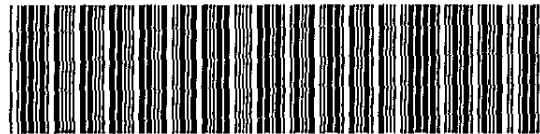

Article I – Name

The name of this corporation is: OLDENGLEWOOD CORP.

Article II – Duration

This corporation shall have perpetual existence.




