**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
KREHER ARCHITECTS, INC.**

Kreher Architects, Inc., a Florida corporation (the "**Corporation**"), in order to amend its Articles of Incorporation in accordance with Section 607.1003 of the Florida Business Corporation Act (the "**Act**"), does hereby deliver the following Articles of Amendment in accordance with Section 607.1006 of the Act:

FIRST: The name of the Corporation is Kreher Architects, Inc.

SECOND: These Articles of Amendment contain an amendment to the Corporation's Articles of Incorporation, as originally filed on January 15, 2004, (the "**Articles of Incorporation**"), requiring shareholder approval.

THIRD: The Articles of Incorporation is hereby amended as follows:

- (a) Article I of the Articles of Incorporation is deleted in its entirety and replaced with:

"ARTICLE I

Name

The name of the corporation is Kreher Wehling Jacquette Architects, Inc.

FOURTH: The amendment herein was adopted and approved on March 15, 2016 (the "**Adoption Date**"). These Articles of Amendment were duly adopted and approved by a majority of the members of the board of directors and a majority of the shareholders of the Corporation pursuant to Sections 607.0704 and 607.0821 of the Act pursuant to actions by written consent of the board of directors and the shareholders of the Corporation, each dated as of the Adoption Date.

FIFTH: The number of votes cast for these Articles of Amendment by the shareholders of the Corporation was sufficient for approval.
