ARTICLES OF INCORPORATION OF  
MS COUNSELING SERVICE, INC.

The undersigned, acting as incorporator of a corporation and pursuant to Chapter 607 and 621 Florida Statutes, adopts the following articles of incorporation:

ARTICLE I

The name of the corporation, hereinafter referred to as the "Corporation" is MS Counseling Service, INC.

ARTICLE II

The street address of the Corporation's principle office is: 6781 Greene St., Hollywood, FL 33024

ARTICLE III

The period of duration of the Corporation is perpetual .

ARTICLE IV
